The Common Council of the City of New Haven, Indiana, met at the City Administration Building on the 18th day of February at the hour of 7:00 p.m. in regular session in accordance with the rules of the Council.

The meeting was called to order by Steve McMichael who presided.

On call of the roll, the members of the Common Council were shown to be present or absent as follows:

Terry Werling made a motion to approve the minutes of the February 4, 2020 meeting as mailed. Dave Cheviron seconded the motion and the motion was approved.

Title VI Survey

Keith Schlegel gave an update on the first ever 3R Project in the state of Indiana. One thing is the ordinance bond is going to need to be passed and read in one meeting so that the timeline can be met.

The first item on the agenda was the introduction of an Ordinance Rescinding Ordinance G-00-11 and Adopting the within Ordinance Reestablishing Criteria for the Review of Applications for Economic Revitalization Area Designation.
