MINUTES OF A REGULAR MEETING OF THE COMMON COUNCIL
OF THE CITY OF NEW HAVEN, INDIANA

The Common Council of the City of New Haven, Indiana, met at the City Administration Building on the 18th day of May 2021 at the hour of 7:00 p.m. in a regular session in accordance with the rules of the Council.

The meeting was called to order by Council President Craig Dellinger who presided.

Council President Craig Dellinger asked everyone to stand and recite the Pledge of Allegiance.

Title VI Statement

Under new business Item A was the introduction of an Ordinance Amending Ordinance No. A-20-16 Entitled "An Ordinance Fixing the Salaries of Each and Every Employee, Deputy, Assistant, and Department and Institutional Head of the City of New Haven, Indiana for the Year 2021". The amendment was eliminating Police Administrative Assistant and adding Records Administrator. The salaries of Police Record Clerk went to a range \$36,000-\$44,000 and Records Administrator was given a salary of \$47,520.98. Council President Craig Dellinger declared Ordinance A-21-14 to have passed.


